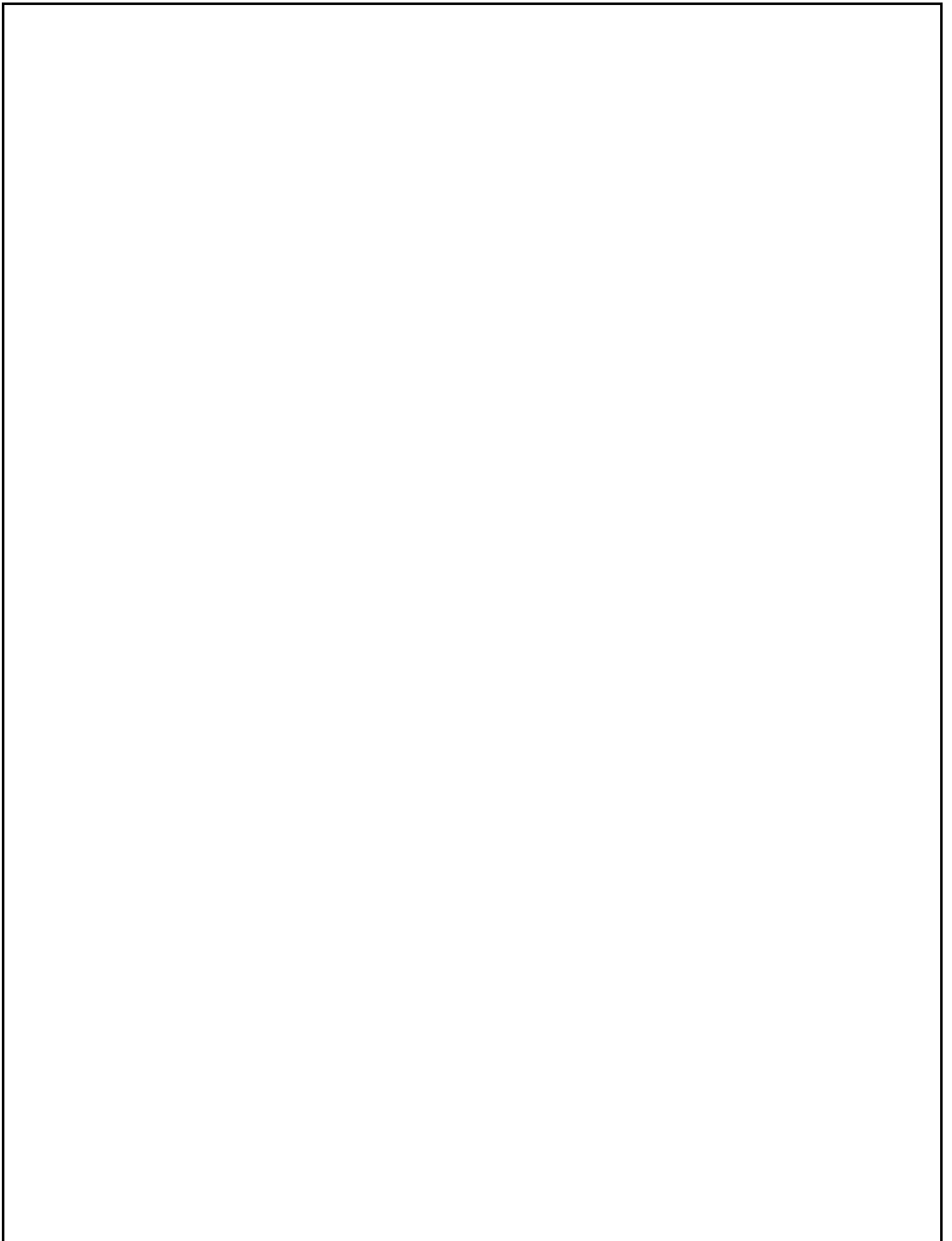

NCRKPO VOLUNTEER AFFIRMATION

14. Section 5903 (c) or (d) (relating to obscene and other sexual materials)
15. Section 6301 (relating to corruption of minors)
16. Section 6312 (relating to sexual abuse of children)

2. An offense designated as a felony under the act known as, "The Controlled Substance, Drug, Device and Cosmetic Act", (the Act of April 14, 1972 (P.L. 233 No. 64)).
